The merger agreement Reinvent Technology Partners and Joby Aero, Inc. became effective on August 10, 2021. The Reinvent Technology Partners Units, Units, each consisting of one Class A ordinary share and one-fourth of one redeemable warrant, automatically separated into the component securities upon consummation of the Business Combination and, as a result, no longer trade as a separate security. The Exchange also notifies the Securities and Exchange Commission that as a result of the above indicated conditions this security was suspended from trading on August 11, 2021.
